Thank you...sorry for the delayed response. It's been very busy during landscaping season.

As per my understand, you're requesting 16 mowings, 8 of which will not include weed/whacking and edging, the other 8 will include those services.

Here is that cost breakdown:

8 mowings without weed whacking and edging: \$170 each (\$1360 total)

8 mowings with weed whacking and edging: \$200 each (\$1600 total)
